5. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Gilfach House, William Street, Gilfach, Bargoed CF81 8ND by 5 p.m. on 27 April, 2021.
6. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Gilfach House, William Street, Gilfach, Bargoed CF81 8ND by 5 p.m. on 6 May, 2021. The physical incapacity must have occurred after 5pm on 27 April, 2021. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on 27 April, 2021.
