HENRY ROBERTS LANE RISCA TEMPORARY PROHIBITION OF DRIVING ORDER 2024

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along

Henry Roberts Lane, Risca between B4591 Risca Road and Pontymason Lane for a distance of approx. 380 metres.

The proposed Order is expected to commence on 5 January 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 28 January 2024.

Access for pedestrians and emergency service vehicles will not be maintained.

Alternative routes are via local roads.

The reason for making the Order is to allow for drainage works.

The order is required by Caerphilly County Borough Council.
