THE COUNCIL'S EQUALITIES STATEMENT

This Council recognises that people have different needs, requirements and goals and we will work actively against all forms of discrimination by promoting good relations and mutual respect within and between our communities, residents, elected members, job applicants and workforce.

We will also work to create equal access for everyone to our services, irrespective of ethnic origin, sex, age, marital status, sexual orientation, disability, gender reassignment, religious beliefs or non-belief, use of Welsh language, BSL or other languages, nationality, responsibility for any dependents or any other reason which cannot be shown to be justified.

The Council is required to have due regard to the need to:

- eliminate unlawful discrimination, harassment and victimisation and other conduct that is prohibited by the Equality Act 2010
- advance equality of opportunity between people who share a relevant protected characteristic and those who do not
- foster good relations between people who share a protected characteristic and those who do not.

The Act explains that having due regard for advancing equality involves:

- removing or minimising disadvantages experienced by people due to their protected characteristics
- taking steps to meet the needs of people from protected groups where these are different from the needs of other people
- encouraging people with protected characteristics to participate in public life or in other activities where their participation is disproportionately low.

The protected characteristics are:

- Age
- Disability
- Gender Re-assignment
- Marriage and Civil Partnership
- Pregnancy and Maternity
- Race
- Religion, Belief or Non-Belief
- Sex
- Sexual Orientation
- Welsh Language*

* The Welsh language is not identified as a protected characteristic under the Equality Act 2010, however in Wales we also have to treat Welsh and English on an equal basis as well as promoting and facilitating the use of the Welsh language.

PURPOSE OF THE PROPOSAL

1	<p>What is the proposal intended to achieve? <i>(Please give a brief description and outline the purpose of the new or updated proposal by way of introduction.)</i></p> <p>In 2016, as part of the Council's Medium Term Financial Plan, the Authority entered into self management agreements with twenty bowls clubs across the county borough. Part of the scheme involved the payment of an annual grant to assist clubs to undertake non-specialist tasks identified in the agreement (opening, closing and cleaning of the building, litter picking, brushing the bowling green etc.). In addition to the annual grant, clubs would be permitted to retain all income from their members for season ticket purchase and any ad-hoc visits by members of the general public.</p> <p>The original payment was for £2,500 (per club) which diminished by £500 per annum, this equates to £10k (per annum). Whilst continuing with the current self management agreements, this proposal offers the £10k to achieve savings as part of the overall Council's Medium Term Financial Plan target for 2019/20.</p>
2	<p>Who are the service users affected by the proposal? <i>(Who will be affected by the delivery of this proposal? e.g. staff members, the public generally, or specific sections of the public i.e. youth groups, carers, road users, people using country parks, people on benefits etc. Are there any data gaps?)</i></p> <p>The reduction in financial assistance from the Council will affect the twenty bowls clubs across the county borough that uses the facilities.</p>

The self management arrangement has allowed the Council to achieve significant financial savings in previous years and retain service provision within local communities. This proposal has no effect on staff.</p>

For any member of the general public who attends a site and play bowls, they will not be affected by this proposal.</p>

The agreements were initially for two years to ensure the process operated seamlessly but the overall savings proposal is for £50K over the five years of the proposal. It is deemed that following the five year proposal, clubs would be financially viable and able to continue to operate the facility without the grant payment from the Council.</p>

	<p>The initial self management agreements, drawn up in 2016 were for two years to monitor the effectiveness of the scheme, which has proven very successful. There is regular dialogue with clubs to ensure any issues are dealt with quickly and effectively. The Council will be issuing letters to all clubs to formally extend the agreement for a further period of time.</p>
