**Temporary Prohibition of
Pedestrians Order 2022**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

The section of Footpath Numbers 188/1 and 187/2.

Pedestrian access will not be maintained.

The alternative route for pedestrians will be available via the local highway network.

The temporary order will be effective from 18th January 2022 up to a maximum duration of six months or until the works are completed.

The closure is required by BECT Building Contractors Ltd.

The reason for making the Order is to allow for construction works on building adjacent to footpath.
