**What is the proposal to be assessed?** Provide brief details of the proposal and provide a link to any relevant report or documents.

The proposal is to mothball the building and to close it to the public and to cease operation of the current museum, gallery, shop and coffee shop. Efforts to carry out a Community Asset Transfer (CAT) will be made in 2024-25. This will remove the subsidy burden for the Authority.

The remaining budget requirement for 2024-25 relates to ongoing staffing costs for the officers employed at this location, 2 officers will be transferred to Llancaiach Fawr Manor and the 1 remaining officer will be redeployed in due course. There is also an ongoing utilities and maintenance budget need as the building will remain open for its tenants.

Involvement	As mentioned above, this proposal will form part of the overall budget consultation which will be available to the public for comment during the consultation stage. There has been direct engagement with staff, Cabinet, CMT and the current tenant (CCBC Employability Team).
